Applicants need to apply once per season with the application found on our website at www.familyroomlaytonsville.com.

#### Market Vendors

We are currently accepting Farmers and Vendors in all categories. Please note the Market is open to handcrafted, local vendors. We do not accept applications for resale or retail items including direct sale and multi-level sales.

Market Participants/Vendors are required to do a Market walk thru with the Market Manager prior to the first attended Market Day. On Market Day, vendors may setup starting at 8:00am and must be set in place and

vehicle moved from the staged area by 8:30am. Vendors are responsible for clean-up of their assigned space and removal of their own trash prior to 2:00pm.

Vendor Spaces are limited to (one) 10 x 10 space unless a vendor requests additional space. **All vendors are** required to bring their own tent and **25lb**. weights to anchor their tents.

Once The Market has reached a determined number of vendors, TFR will limit the amount of vendors in each category.

The Market Manager and TFR reserve the right to terminate any/all vendor agreements.
